British Columbia & Yukon Development Fund

History: The BC & Yukon Development Fund was established in 1995. The capital of \$15,000.00 was derived from an excess of funds from the hosting committee (all 6 Dioceses of the BC & Yukon Council) for the National Convention in Vancouver in 1994. The Provincial Council matched this fund at that time. In 2002, the capital amount was raised from \$30,000.00 to \$50,000.00, the amount derived from general funds of the Provincial Council. The amount of the grants available each year is determined by the interest derived from the capital fund investment.

The BC & Yukon Council firmly believes that the best *training for the League* is attendance at conventions at all levels and that this is the *primary purpose of the fund*. It is also recommended that all levels of the League be encouraged to send as many accredited delegates that are eligible to attend.

Criteria Development Fund # 1

Provincial Development Travel Fund to Assist Delegates to Attend the Provincial Convention

1. The Provincial Development Committee will consist of the President of the Provincial Council, the President-Elect, the Past President and the Treasurer. The President may appoint additional members as she see fit.
2. The Provincial Development Fund will be dispersed one (1) time each year upon a needs assessment review of the applicant by the committee.
3. Applications should be submitted on the appropriate and latest revised forms by March 15th of any given year. The form should be completed in full. The applications will be considered by the committee and judged on the accuracy of this application form.
4. Please note that one applicant per form only will be considered and she must be a delegate to the provincial convention.
5. The committee will reach a decision and all applicants submitting forms will be notified of the outcome of their request within 30 days (April 15th).
6. Assistance to send delegates to a provincial convention will only cover 2/3 maximum of the bus fare to the convention site. The actual total amount of the grant available will be determined by the funds available in that given year. No other expenses, i.e. hotel or meals will be considered and will be the responsibility of the individual, the parish or the Diocese.
7. A report of the convention attended and applicable receipts must be submitted to the Provincial Organization Chairperson within 30 days of convention.

Purpose: to assist BC & Yukon Diocesan Presidents financially to attend a National Convention.

History: In 2002, a separate fund was established to assist Diocesan President to attend National Convention. This is a constant sum of \$1,000.00 awarded to a Diocesan President who makes application for assistance to attend a National Convention. The grant is available once during a Diocesan President's two year term. It is to be hoped that the Dioceses who can afford to send their President each year will not apply so as those that cannot afford to send their President may take advantage of this fund. Again it is the firm belief of the Provincial Council that attendance at convention at all levels is imperative for the growth of the League.

The funding for this grant is derived from the general funds of the Provincial Council.

The successful candidate must complete a report form and submit receipts to the Provincial Organization Chairperson or her designate within thirty (30) days of the convention.
